He has also five waiting to go to the Department of Corrections and four will be going this week. Scott also stated that all of the vehicles with deer damage are repaired and the cost was probably over \$50,000.00 dollars. He does have a motorcycle and two Chargers that he is going to have Sullivan's auction off for him at their up coming sale. Scott discussed with the members the HB3653 that is laying on the Governor's desk to be signed and every one is thinking he will take the whole thirty days he has before he signs it. Scott was asking if the County Board would do a resolution stating they are opposing this HB3653, as a lot of other counties are doing. After more discussing a motion was made by Patsy Davis to have a Resolution written up and sent to the full board to approve saying we are against this HB3653. Andrew Asbury seconded the motion. The letter they received from the State was corrected and they did send another one back to Scott. Scott has one Jailer that is out of school and working and has two more waiting for their schooling. He also has a new woman deputy that is waiting to go to training.

Dennis stated that all office holders need to have a correct inventory of their department and if new items, then add them on and if some need to be deleted than that should be done.

Fifty-four claims were reviewed for payment by the members and a motion was made by Andrew Asbury to present these to the full board for payment. Patsy Davis seconded the motion. All voted aye. Motion carried.
