- pg 10 Article 10 Section 6- Remove the sentence "No one may bump an employee out of a shift within twenty-four hours of the start of the shift."
- pg., 12 Article 13 Section1- Take out the () after each of the hours of vacation offered full time employees, it should read only the hours received.
- pg 20 Article 19 Section 12 (a) and (b)- please change the statue to probationary period to align with the other verbiage in contract.
- pg 22 Article 20 Section 4- Remove whole section, it is covered by Article 19
 Section 12 no need for repeated section

Roll call was taken with all members present voting "Yes," motion carried.

Mr. Blythe asked about Outreach using the northeast corner of the courthouse lawn and that request has been turned over to the Building commission. Ms. James discussed the sale of the EMS building and that she and Ms. Wilde-Tillman are working on insurance for coverage of contents.
